President's Address

I have just returned from marching with 3,000 others in Santa Barbara, California (a small town) as part of the March for Women's Lives against the policies of the Trump administration and for reproductive justice, immigrant rights, and climate activism. In front of the White House during the DC component of this march, the Chilean feminist collective Las Tesis performed "Un violador en tu camino (a rapist in your path)" as an act of global feminist solidarity against violence against women. Others protested the violence of war, dispossession, police profiling, and poverty. Meanwhile, here in the USA, we have entered another year of commemorating women's suffrage, having finished marking the legacy of 1619 - the time when Africans found themselves transported to the Americas as a forced labor force. But not all women gained suffrage or equal rights and the ways that race/ethnicity/caste/class and other factors shaped the meaning of freedom haunts us vet.

Turning outward, it feels as if we are living in the days before, just like the transnational feminist movement before each of the 20th century's world wars, hot and cold. Our connections - North and South, East and West - seem even more important during periods of ethno/racial nationalism and anti-gender politics, especially amid the global supply chains,

gig economies, and the corporatization of the university that so many of us face (others of us never experienced secure jobs and relative prosperous times for academics). Power imbalances between nations and within them, between tenured and contingent professors, between stars and the rest pervades the academy and reminds us that our world is the real world. The knowledge we generate as historians of women and gender, shared through our networks like this one, seems crucial to show what is has not always been, alternatives have existed, but the present derived from the past. Another world is possible!

To strengthen such connections, we will meet again in Poznań, Poland in August along with the Congress Internationale of Historical Sciences. I am happy to report that we were able to get additional time slots from CISH, so able to accommodate all panels, though it means Saturday sessions. What a wonderful and rich program we will offer. A preliminary listing is in this newsletter. I thank Adele Perry and Francisca de Haan for their leadership and our Polish women's historian colleagues for their insights and work as well. An update on the solidarity dinner, business meeting, and cultural events will be in the next newsletter and posted on our webpage. We will award the

first Ida Blom-Karen Offen Prize at the meeting!

In addition, we have two double sessions accepted for the CISH main program, one on trade union women organized by Susan Zimmermann and the other on anti-genderism organized by Maria Bacur. There is also a joint session with the International Social History Association, another affiliate, on gendering the history of capitalism that I organized. We will include these other sessions and an update on the entire CISH program in our Summer Newsletter. Information and early bird registration on the CISH meeting can be found at:

NEWS FROM NATIONAL COMMITTEES



Argentina

AAIHMEG (Asociación Argentina para la Investigación en Historia de las Mujeres y Estudios de Género)

During July we participated in the XIV Conference on the History of Women and IX Ibero-American Congress of Gender Studies "Intersections: feminisms, theories and political debates". The conference had an extraordinary attendance: more than 3000 researchers and activists from all over the country and from different parts of Latin America gathered in Mar del Plata. There were interesting book exhibits, conferences, special panels and cultural activities which strengthened the challenge of a society increasingly committed to the fight against multiple inequalities. We also started an affiliation campaing during the conference with a booth where colleagues could obtain information about AAIHMEG membership and its activities.

We have also completed important projects. At the end of July, the results of the first call for the Doctoral and Doctoral Thesis Award of the AAIHMEG were published (image above). The works of Ludmila Scheinkman and Gabriela Mitidieri, both researchers based in the UBA, were winners and will be edited in the coming months by EUDEM. The doctoral theses of Anabella Gorza (UNLP) and Daniela Bianchi (UBA), as well as those of Victoria Marquinez (UNMdP), Sabrina Rumiz (UNAJ) and Sacha Lione (UNL) received honorable mentions. The prize seeks to be an incentive and support for young researchers and researchers at a time when the budget cut has made the scientific system an expulsive environment.

We also had our annual Assembly to elect the new authorities. The new Board of Directors is composed of representatives of the research centers and institutes from various parts of the country that integrate in the association (UNR, UBA, UNTref, UNMdP, UNNE, UNLP, UNLPam, UNCuyo, UNC, UNL, UNT, UNICEN, UNSJB, UNPA, IJVG). The renewal of authorities means new projects and collective challenges.

In December we launched our website, which is the result of many months of work carried out by our members Andrea Torricella, Ana Lía Rey, Valeria Venticinque and Valeria Pita. The page is a key element in the communication policy of the AAIHMEG, which, together with the activities that we keep in social networks, will allow us to gather information and publicize the activities and productions carried out by members of the whole country, disseminate news, and host the association's publications. We want the page to allow greater possibilities of participation, that is the letter of introduction to other associations and research and training institutions, that allows us to articulate our work with that of feminist groups, student centers, and trade associations that face the challenge of thinking gender and sexuality.

Australia

THE AUSTRALIAN WOMEN'S HISTORY NETWORK (AWHN) enjoyed a busy and productive 2019.

AWHN Annual Symposium

The AWHN's annual symposium took place in October, with the theme "The Female Frame: Biopolitics and Wellbeing in Australian and Global Perspective." Hosted by the University of Western Australia (UWA) in Perth, this was the first time in the AWHN's 32-year history that the symposium had been held in Western Australia. The decision to organise the symposium in Western Australia was part of a concerted effort to further confirm the AWHN's truly national profile, and to engage more closely with scholars working in this part of the country.

The symposium drew on the concept of the "female frame" as a catalyst for discussion on the way bodies are socially constructed and gendered. This concept encompassed a range of scholarly inquiries, from the topic of women at work to reproductive rights and female friendships. Participants considered this topic from multiple perspectives — aesthetic and economic, physical and psychological, colonial, political and historical — and examined the question of how the female frame can be a function, source, and signifier of change and growth both within Australia and globally.

The symposium was opened with a keynote speech from Tanya Fitzgerald (University of Western Australia) entitled "In the Frame: Academic Women and Intimate Friendships, 1920-1960." A public lecture by Ann Curthoys (UWA) closed the proceedings. Organised in partnership with the UWA Institute of Advanced Studies and the Australian Academy of the Humanities, Curthyos gave a lecture entitled "An African-American Feminist Visits Perth in 1960: Who She Met, What She Saw, and What She Wore." A special issue of the AWHN journal *Lilith: A Feminist History Journal*, based on papers presented at the symposium, will be published in 2020.

Lilith: A Feminist History Journal

The 25th issue of *Lilith: A Feminist History* Journal was published this year, and included a suite of articles that contribute to conversations on the relationship between women and the State. The seven original pieces span from early modern England, to the settler-colony of New South Wales, and to present day Melbourne. These pieces consider the "woman" as she is circumscribed by law and society: women as the focus of wartime legislation; women as active participants in the English legal system; and the way that "woman" has been used as a label for transgender criminals. In a more methodological turn, these articles also question what it means to be a woman of colour and a female academic in 2019, and challenge what exactly "feminist history" means. http://www.auswhn.org.au/lilith/current-issue/ Policy and Advocacy In 2019 the AWHN made a submission to the joint review of the Australian and New Zealand Standard Research Classification (ANZSRC), advocating for introduction of a research category for Gender History, which would include the study of women's history, the history of masculinity, and the history of sexuality as a distinct field of study under History. This category is long overdue in our research classification system, and we feel that its introduction will serve to raise the visibility and importance of the work conducted by our Members. Members Honours

Our Members were very successful in the 2019 round of the Australian Research Council Discovery Projects scheme. Recipients included Joy Damousi for a project on the cultural, social, and psychological aftermaths of wars between 1815 and 1950; Jane Lydon, Amanda Nettlebeck and others for a project that investigates the ways that visual images have defined, contested and advanced ideas of Australian citizenship and rights from European settlement to the present; Victoria Haskins, Claire Lowrie and others on a project that looks at female domestic care workers from India and China who travelled to Australia and elsewhere during the period of British colonialism; and Katherine Ellinghaus, Rachel Standfield, Sianan Healy and others for a project on hidden histories of Aboriginal, Torres Strait Islander, Maori and Pacific Islander travel to and across Australia, which aims to understand meanings associated with travel and the implications for sovereignty and identity. We look forward to sharing more of their research as these projects develop.

Vera Mackie is DAAD Visiting Professor of Japanese Studies at Heinrich Heine University of Düsseldorf from October 2019 to January 2020. She will also present lectures at the Ruhr University of Bochum, University of Eirlangen-Nuremberg, Freie University Berlin, the University of Heidelberg and the University of Freiburg.

Iva Glisic is recipient of the 2019 Early Career Research Small Grants awarded by the Herbert and Valmae Freilich Project (Australian National University), which assists research into the causes, histories, and effects of ethnic, cultural, religious and sexual bigotry and animosity. The Grant will support her project "The Art of Justice in the Western Balkans," which explores the emergence and the role of activist art in post-conflict societies.

RESEARCH PROJECTS

The research project Separated Beds -Interwoven Property. Regulation of separation consequences since the 16th century (OeNB Nr. 17913), which started in October 2018 and will run until December 2020, asks questions about the separation and divorce consequences of failed marriages between the 16th and 19th centuries. The civil courts in the archduchy of Austria below the Enns will be the focus of investigation. Building on the research findings from two FWF-funded projects, the project is interested in the regulations for the time in which the spouses were allowed to live separate – for a limited or unlimited time period - from each other. How was the mutual property divided or, respectively, were the maintenance payments determined? Who had custody over the sons or daughters, and until what age? Going beyond the jurisdiction handed down in the marriage proceedings, the project asks about the consequences of a divorce in everyday life. The research project is directed by Andrea Griesebner from the Department of History at the University of Vienna, Birgit Dober, Susanne Hehenberger, and Isabella Planer are further members of the research team, Beate Pamperl is responsible for the database and the web portal, Jennifer Blaak for translations into English. 

About the book: They call themselves *The* Filipino Pioneers, the generation of workers who came to Denmark from 1960 to 1973. It was the era of European "guest worker" recruitment that in Denmark ended in November 1973, when the government adopted a so-called immigration stop. At the same moment, however, the Philippine government was in the process of creating a labor export program. Despite the immigration stop, Denmark was, by the end of the 1970s, on the list of countries served by the new Overseas Employment Development Board, which was already deploying Philippine workers to more than one hundred countries. During the second half of the twentieth century, labor markets and forms of migrations were reconfigured through global entanglements as well as local events. Labor Pioneers traces the lives of Filipina workers in Denmark from the 1960s until today, and situates their trajectories within a history of labor trading policies crafted in the twentieth

century by local officials, authoritarian rulers, trade unions, and international organizations.

held three regular meetings. On July
21, Minoru, Omori(大森実) gave the
presentation on "Tracks of women's grassroots movements chasing 'the Socialization of
Elderly Care' and realization of a new civil
society in

Japan: Focusing some activists of Osaka in the 1980s and the 1990s". On October 19, Yoko Ijuin(伊集院葉子) gave the presentation

on "The study of ancient female monarch from a gender perspective".

On November 16, Hiromi Sone(曽根ひろみ) gave the presentation on "Penalty and Gender in the early modern period—「OSHIKOME」 and 「SHIKARI」 (confinement and scolding)—".

On June 23, we held the presentation of master's theses. Mariko
Namae(生江麻里子) presented "The Presentation of Clothing in the Heian Period: Women's Robes Gifted to Men". Yuki Murakami(村上由季) presented "Recommendations to Women for Taking Care of Her Own Fingernails in the Late Meiji Period to the Taisho Period".

The 16th annual conference of the Gender History Association of Japan was held at Senshu University on December 8th, 2019. In the morning, eighteen single papers and one panel session were given as the program of its website shows: http://ghaj.jp/en/meeting/index.html. In the afternoon, a symposium was held under the theme of Symbolic Emperor System/Monarchy and Gender. Three stimulating presentations followed after the chair explained the theme: Kumie Inose, "Always staying together with the people": Queen Victoria who opened up the future of monarchy; Tatsuya Nakazawa, Gender representation on the Maria-Theresa in the hereditary/elective succession to the Hungarian throne; and Takeshi Hara, Two Empresses in Modern Japan: Empress Teimei and Empress Michiko. While Mizue Yoshino and Kazuko Hirai co-chaired the symposium, Shizue Osa and Chikako Kato served as commentators.

Exhibitions

SKOGH activities

Seminar: Academic housekeeping

Lund University, 15 October 2019

Lecturer Sara Kalm

Academic housekeeping includes the tasks that must be performed at an academic institution, which are non-meriting, time-consuming and "invisible". At the seminar Sara Kalm presented an article which she has written on this theme. Kalm discussed and specified the meaning of the concept, described how academic housekeeping is distributed, and discussed various explanations for this distribution. No major Swedish study has yet been done on this topic, so Kalm presented international research and discussed this in relation to the Swedish case. Existing research indicates that women perform most of the academic housework, which seems to be related to gender norms and research ideals. One argument put forward is that the unequal distribution of housekeeping can partly explain women's difficulties in pursuing a career in academia, and that it should therefore be taken more seriously than previously done.

After Kalm's presentation followed discussions in small groups about the situation at Lund University and a concluding discussion.

Half-day session focusing on gender in history teaching and current gender historical research

Lund University, 18 November 2019

1. Roundtable discussion on gender perspective in history teaching.

How can we teach with a gender perspective in a good way, what pitfalls exist and how does a clear gender perspective influence the planning and implementation of major courses? Associate Professor Henric Bagerius (Örebro University) and Associate Professor Christina Douglas (Södertörn University, Stockholm) talked about their experiences together with Professor Eva Helen Ulvros (Lund University).

2. Short presentations of current gender historical research.

Scholars fro m different departments at Lund University gave 10 minutes presentations in

order to give an overview of some of the gender historical projects currently conducted.

The presentations were concluded with a mingle and conversations in less formal forms.

The study is based on analysis of three women's stories of living under the two regimes - the Soviets and the Nazis. This book narrates about blurred lines between collaboration and righteousness, between resistance and aloofness, about despair and survival, about choosing strategies for living and dying. The book examines women's painful search for proper words and ways for self-description as they negotiated their inner incentives and propaganda-imposed ideas about the 'correct behavior' under occupation. It reveals the formation of state policies of stigmatization of those who survived occupation and explores the process of selfstigmatizing of people who considered themselves the Soviet citizens. The three women's stories show the complexity and nonlinearity of wartime experiences: the first woman attempted to construct her biography as a heroic one, the second fearlessly struggled for survival, and the third woman was saving her countrymen despite the risk of punishment from the Nazi or Soviet authorities.

This book explores the trajectories of women's emancipation in the interwar Poland. The study focuses on female activists whose thoughts and actions contributed to refutation of prevailing gender stereotypes and creation of a new image of women. The author reveals women's history in the context of those days' society, taking into account the crucial role of Church and the national dimension in women's lives. Thus the origins and activities of Polish, Ukrainian and Jewish women's groups are examined and compared to determine what was common and what was specific in their goals and practices.

Call for Submissions: Backstories: The Kitchen Table Talk Cookbook

Food brings people to the table and dialogue ensues. While sharing food we exchange information and ideas, but also elements of our personal lives. We nourish each other with sustenance and knowledge. Food consumption is one site where even humans living in urban environments encounter rurality on a daily basis. Reflecting the theme of our upcoming 14th Triennial Conference in 2021, "Kitchen Table Talk to Global Forum," the Rural Women 's Studies Association will publish a cookbook with The Digital Press at the University of North Dakota featuring membercontributed heirloom recipes that relay family history, cultural heritage, and personal memories associated with the dishes. Backstories: The Kitchen Table Talk Cookbook will honor female tradition while

producing a volume that elevates cookbooks to a scholarly level, reflecting the themes associated with the conference including food production, preparation, rituals, hospitality, etiquette, and display. It will consider how recipes transmit significance, meaning, and culture, appealing to an audience that craves a serving of knowledge alongside their food.

Sharing recipes that produce our favorite dishes is a form of intimate conversation. Our cookbook will present diverse regional foodways across centuries and from around the world. These might include anything from simple 18th-century farm "receipts" to contemporary vegan dishes. Backstories: The Kitchen Table Talk Cookbook will consider social aspects of eating and gathering that have empowered women to form organizations that benefit them as a group and society as a whole. It will mirror the global nature of the Rural Women's Studies Association.

Backstories: Kitchen Table Talk to Global Forum draws on a long tradition of women's clubs producing cookbooks as fundraisers for their organizations. In keeping with that tradition, we will collect cherished recipes from our members and allies. But Backstories will be much more than just another fundraising cookbook. As an organization that unites historians, sociologists, anthropologists, and community activists, we aim to enhance our recipe collection by providing brief essays that situate them in their social and cultural contexts. The recipes will be accompanied by brief contextual essays—ranging from 50 words to 500—that explain how the recipe was collected and used, and how it reflects rural women's culture in a particular place and time. We will unite these recipes with scholarly essays, including an editorial introduction will provide a historical overview of how recipes and cooking have varied over time and place, and several longer thematic essays on foodways.

We invite a wide variety of contributions to this volume, including:

- Scholarly introduction examining the history of cookbooks and discussing how they can be used to understand foodways, women's work, and more
- Thematic essays (1,000-10,000 words), including:
- History of foodways
- Anthropologies of food
- Food Studies research
- Recipes accompanied by brief stories or commentaries, including:
- Historic recipes collected from cookbooks and other primary sources
- Favorite family recipes
- Contemporary recipes
