# 'Women's Histories: The Local and the Global' - call for papers issued

The next conference of the IFRWH is now fixed for Sheffield, UK, from 29<sup>th</sup> August to 1<sup>st</sup> September 2013. <u>This newsletter contains the call for papers</u>: please follow the link there to the special conference website, where you will find further details, including the online proposal submission form. There will be a link to this special conference website from the main IFRWH website.

I am feeling very excited about this conference, which should be the largest conference on women's history ever to be held in Britain (though perhaps not in the UK as a whole: Mary O'Dowd organised an enormously successful IFRWH conference in Northern Ireland some years ago). The conference is being jointly organised with the Women's History Network, our national affiliate in Britain, who celebrate their 22<sup>nd</sup> annual conference in 2013.

Please submit your proposals for papers and panels by the deadline of 31<sup>st</sup> October 2012. Note that we want this conference to be inclusive: if your own research does not itself explore local-global connections or transnational approaches you can propose a paper or panel (of 2-3 papers plus commentator) for inclusion in strand 9 on 'national women's histories in comparative perspective'.

Conference registration will not open until 31<sup>st</sup> January 2013. Meantime, please check the conference website periodically as further

details on the programme outline and associated special events, accommodation and registration fees will be added over the coming months.

Please circulate the call for papers as widely as possible within your own countries to ensure that we get a large and strong submission of paper proposals.

# International Congress of Historical Sciences (CISH) conference in Jinan, China in 2015.

We sent in an impressive set of proposals for the main CISH conference, thanks to all your efforts. Karen Offen, who is on the CISC committee, tells me that our proposals did well in the initial discussion of themes/sub-themes/roundtables, and she has made suggestions to the board about how gender and women can easily be encompassed within other theme proposals. The final decision on themes etc. will be made at the CISH congress in Budapest this September, which I will attend as a voting delegate representing **IFRWH** (each organisation is allowed to send one delegate). So please wish Karen and I luck in securing a good showing for women's history in the final selection of themes.

I hope to also use the opportunity to meet up with leading Hungarian historians of women, and encourage them to form a new IFRWH affiliated committee in Hungary, building on Krassimira Daskalova's earlier successes in fostering new committees in Central and Eastern Europe. Meantime, discussions are currently underway about forming new committees in Ghana and in southern Africa.

#### CALL FOR PAPERS

Women's Histories: the Local and the Global

This international conference will explore the history of women worldwide, from archaic to contemporary periods. Engaging with the recent global and transnational turns in historical scholarship, it will examine the ways in which histories of women can draw on and reshape these approaches to understanding the past. It will focus on developing gendered histories of globalisation that explore the complex interplay between the 'local' and the 'global', and on exploring the relationship between nation-based traditions of women's history writing and transnational approaches which examine connections and comparisons between women's lives in different localities. Key questions to be addressed are:

- How can women's histories reshape our understanding of the relationship between the 'local' and the 'global'?
- What implications does a transnational framework of analysis have for nation-based traditions of writing women's history?

## Keynote speakers will include:

Mrinalini Sinha, Alice Freeman Palmer Professor of History, University of Michigan. Catherine Hall, Professor of Modern British Social and Cultural History, University College London.

#### Strand themes:

- 11. The place of the global in local, community and public histories of women.

# RESEARCH PROJECTS AND UPCOMING CONFERENCES

Gabriella Hauch (University of Vienna) is working on a women's history of Linz in the 19<sup>th</sup> and 20<sup>th</sup> centuries, a book project commissioned by the city of Linz. One aspect of the book deals with women active in politics and culture in the course of the development of this town to an industrial metropolis. It is particularly interested in the tension in its relationship to Vienna, the state's capital, and how this tension between periphery and center is reflected in Austrian women's and gender history, especially the history of the women's movement. Tracing Austrian women's and gender history over different socio-political periods along the example of Linz reveals ambivalences and disjunctions evident in gender relations at the periphery. The distinctive political ruptures in Austrian history, examined from perspective of gender history, are a further focus of the book.

"The Culturalisation of Gender: (Dis-) Continuities between Gender Theory and Iconic Body Imaginations" (Die Kulturalisierung von Geschlecht: (Dis-) Kontinuitäten zwischen Gender-Theorien und bildhaften Körper-Imaginationen) is the theme of a conference to be held at the Justus Liebig University of Gießen (in Germany), October 12-13, 2012. Organised by Andreas Langenohl (University of Gießen) and Anna Schober (University of Vienna), it will focus on how changes in the academic discourse of "gender" and political and public negotiations of this category relate to each other in visual culture in public space. The conference will explore the nexus between genealogies of current culture-oriented, constructivist definitions of gender and social and aesthetic practices as well as body imaginations. Its goal is to discuss and critically review the ambivalent effects and links of the initially academic, later iconical-imaginative public and "culturalisation" of gender.

## Femmes de pouvoir, femmes politiques durant les derniers siècles du Moyen Age et au cours de la première Renaissance (Eric Bousmar et al., red.)

Dans l'histoire des structures politiques de l'Europe, le rôle des femmes de pouvoir reste encore à l'heure actuelle, pour le Moyen Age et le début de l'Epoque moderne, une réalité trop peu étudiée ou encore trop souvent réduite à ses dimensions purement biographiques ou anecdotiques. Par ce volume, fruit d'un colloque international organisé en 2006 à Lille et à Bruxelles, les éditeurs apportent leur pierre à cet édifice neuf qu'est la nouvelle histoire du pouvoir au féminin, champ d'études au confluent de la politologie et de l'histoire des femmes et de la famille. Au fil de trente études de cas dues aux meilleurs spécialistes européens et américains en la matière, ils déploient un véritable point vue comparatiste sur ces femmes de pouvoir, et ce à tous les échelons de la hiérarchie nobiliaire, voire roturière, pour un espace géographique large et une période comprise entre le XIIIe et le XVIe siècle. Ils tentent, par là, de répondre à des questions aussi fondamentales que celles des modalités de l'exercice du pouvoir au féminin, de l'accession à ce dernier et de la manière dont la société médiévale - a priori hostile aux filles d'Eve – perçoit ce pouvoir.

Marie-Amélie Bourguignon and Bernard Dauven on 'Femmes victimes et coupables dans les Pays-Bas bourguignons au XV<sup>e</sup> siècle'

Les sources de la pratique judiciaire du XV<sup>e</sup> siècle dans les Pays-Bas bourguignons font apparaître, classiquement, le faible nombre des femmes présentes en justice. Elles y sont pourtant bien présentes et capables. On note l'aspect ordinaire des crimes et délits pour lesquels elles sont condamnées. Loin d'être marginales, les coupables sont « ordinaires » d'un point de vue « social ». Pour autant on voit les stéréotypes à propos des femmes agir sur la conception que s'en font les juges. Au final, au XV<sup>e</sup> siècle, on ne rencontre pas de figure archétypale d'une femme criminelle.

#### Prizes - Prix

#### Johanna Naber Prize 2012

On April 20, the Dutch-Belgian Vereniging voor Vrouwengeschiedenis (Association for Gender History) and Aletta – institute for women's history awarded the Johanna Naberprijs for the best master paper in gender history. Winner of the 2012 edition is Remco van Hauwermeiren (Ghent University), with his paper "The Ogaden war: Somali women's roles and the psychological ramifications".

The jury, composed of Mieke Aerts (professor political history of gender at Amsterdam University), Gita Deneckere (professor social history at Ghent University) and Anaïs van Ertvelde (winner of the previous edition), praised Van Hauwermeiren for his ambitious choice of subject and the way in which he combined archival research and interviews with Somali women living in refugee camps to

look into the role of women in the Ogodan war and how these roles are remembered.

For the first time in its history, the Berkshire Conference on Women's History - the "Big Berks" - will be held outside of the United States, at the University of Toronto. As president of the Berkshire Conference of Women Historians and as Co-ordinator for the CCWH's national fund-raising campaign for the Berks, respectively, we are pleased to announce that the Canadian Committee on Women's History will act as the national cosponsor of the first Big Berks to be held outside the United States. The University of Toronto is hosting the event and other universities and departments across Canada are making significant contributions. We are very excited about hosting this conference and invite members of the IFRWH to plan to join us in Toronto, Canada, May 22-25, 2014.

An international group of nearly 100 people has brainstormed to produce the conference theme and the ten subthemes. They were guided by the shared goal of making the conference as intellectually stimulating, diverse and inclusive as possible. The major thematic areas are:

- Borders, Encounters, Conflict Zones and Memory
- Empires, Nations, and the Commons
- Law, Family, Courts, Criminality, and Prisons

# The CCWH/CCHF and the Canadian Historical Association.

Feminist, women's and gender history was prominent on the program and among prize winners at the May 2012 Annual Meeting of the Canadian Historical Association co-hosted by the University of Waterloo and Sir Wilfrid Laurier University. This reflects the strength of the Canadian Committee on Women's History - Comité canadien de l'histoire des femmes and of feminist research and publications within Canadian history departments and universities. The CCWH/CCHF hosted its usual successful reception for members and others, sponsored two very successful sessions, and individual members gave many interesting papers in sessions on a range of themes. Building on its goal of honouring some of the founders of feminist history in Canada, the CCWH sponsored keynote address by two pioneering feminist historians, Gail Cuthbert Brandt and Andrée Lévesque took the form of a casual conversation about past and present trends in feminist history. And a special roundtable featured the scholarship of Wendy Mitchinson, a pioneer in the history of gender, medicine and the body through reflections presented by her former Ph D students.

In addition, feminist, gender and women's history featured prominently among the many prize winners at the CHA/SHC's annual prize giving ceremony. Prizes and honorable mentions included:

# Independent Scholars Representative Report

Alison Norman, University of Toronto

I recently polled a group of my peers and colleagues who have all graduated within the last two years or so, to get a sense of how people are fairing in this difficult job climate. While the job crisis isn't new – it began in the 1970s and has had ups and downs since then, the situation seems to be much worse since 2008. The responses I got ranged from disappointment to stress, frustration to disenchantment with academia as a whole. Some of my peers have post docs, some teach sessional courses at one or more universities and colleges, and others have various kinds of research contracts. A few have left academia and found employment elsewhere. Some are doing another degree considering Information sciences or in education/teaching to make them more employable. Others have taken the "time off" to have children. Others are entirely unemployed. Everyone is looking for full time work, and finding very little of it. I have no statistics, but it is clear to all that there are very few tenure track jobs each year in Canadian history. And again, I have no statistics, but it seems to many of us that while women seem to make up at least half of the Canadian history PhDs the majority of those iobs have tenure track gone men. Additionally, jobs have gone to people from beyond Canadian universities. This has women graduates from Canadian universities in a difficult position.

Virtually everyone I spoke to was depending on a spouse or partner's salary to live, as it is very difficult to live (and especially to support a family) on a salary comprised of occasional teaching, or contract work. Those lucky enough to have post docs also struggle on an after-tax income of under \$30,000 a year. Most of these jobs come with little or no benefits, including health and dental coverage. Networking and professional development opportunities also seem out of reach with little or no support to attend conferences across the country. The CHA is one of the only conferences that provides funding for presenters who are sessional instructors.

The result of all of this is a generation of PhDs in Canadian history that will be fleeing the field, desperate for fulltime work that provides some job security, benefits, and a proper salary. As part of the CCWH's mandate is "monitoring the status of women in the historical profession and working to raise that status," we need to think about what we can do given the changed the conditions of academic life and labour. Our structure comes from a time when it was assumed that most members were graduate students and tenured or tenure track professors. Today, tenured professors seem to be a minority, while the number of post-docs, contingently employed/underemployed instructors, "alt-ac" historians, and public historians continue to grow. What can the CCWH do to reflect this fact and help to support the "new faculty majority"?

# Diana's Daughters – female hunters then and now

The gender profile among hunters is significant: well over 90 % of those who take out a hunting license in Denmark are men. But changes are coming. More and more women take out a hunting license. Women want to go out into nature, not just to be there but to be part of it. Listen, sense, be alert and react faster than even the most attentive animal.

Who are the female hunters of today, how did their interest in hunting come about and how

do they practice this interest? The Women's Museum and the Danish Museum of Hunting and Forestry decided to examine this in a large joint research project. More than 800 female hunters participated in the study, answering factual questions as well as questions about norms and attitudes. Questions that may help to uncover which myths and prejudices are real and which only exist as handed-down 'truths'. At the same time, the intention was to examine whether the presence of female hunters affect the masculine norms and values that have marked hunting for centuries. Through comparisons to two recent Danish studies of whom and what the hunter is, it is possible to uncover likenesses and differences between male and female hunters; among them the meaning of the hunt to the two genders. For even though they do the same thing at the same time and often together it does not mean that women and men experience hunting in the same way.

The Danish Agency for Culture and the Danish Hunters' Association have supported the project financially, and the Danish Nature Agency has — with the permission of the Danish Data Protection Agency — placed the records or hunting licenses at our disposal.

#### **CONFERENCES**

The one-day conference **«Gender in history:** accounts and case studies», organized by the group 'Historians for Research in Women's and Gender History' (National Committee of Greece, IFRWH), was held at the new amphitheatre of the University of Athens on Saturday 11 November. In the first part of the conference, entitled 'Accounts of historiography from a gender perspective', papers assessed the use of gender as a category of analysis in several fields of historical research, i.e. the history of masculinity, the

history of family, of labor, of education, as well as in the development of school historiography. As case studies in modern Greek history the papers of the second part of the conference examined the formation of gender identities or gender relations in various areas of historical inquiry like education, politics, fine arts, sexuality, the constitution of nation, and the body. A round-table discussion about general methodological and epistemological questions regarding gender in history, social anthropology and urban space studies, closed the meeting. Speakers included A. Dialeti, D. Vassiliadou, L. Papastefanaki, K. Dalakoura, M. Repoussi, M. Preka, E. Kanner, D. Samiou, Y. Yannitsiotis, E. Fournaraki, G. Gotsi, A. Avdela, A. Psarra, D. Vaiou, and E. Papataxiarchis.

The international conference entitled «The Challenge of Gender in the Ottoman, Turkish and Middle-Eastern **Studies:** Attempting an Interdisciplinary Approach» was held in Athens on December, 1st -2nd, 2011. It was co-organized by the Department of Turkish and Modern Asian Studies of the National and Kapodistrian University of Athens and The French School of Athens. This conference took place during the second meeting of the research group working on Gender and Inter-religious Relations in South Eastern Europe and the Eastern Mediterranean  $(19^{th} - 21^{st} \text{ centuries})$  - an international research program running since 2009 and coordinated by both the above institutions. The conference aimed investigating the effects of the uses of gender as an analytical tool on various disciplines (history, sociology, anthropology, etc.) in the context of the Ottoman, Turkish and Middle-Eastern Studies. It brought to the fore subjects such as: gender as an analytical category in the historical/ anthropological etc. research on Ottoman, Turkish and Middle Eastern societies until now; gender as a tool to challenge traditional narratives on nation building or on women in non-Western societies and to problematize orientalist common places still

influential enough in social studies. Emphasis was also given on assessments of the ways gender as a category of social analysis changed the academic communities' views on the respective societies. The participants were historians, anthropologists, sociologists, literature experts from a range of institutions in Turkey, Lebanon, France, Bulgaria, Italy, USA and Greece.

#### **WORKSHOPS**

On March 5, 2012 a workshop on women's biographies and life stories was organized by the American College of Thessaloniki in association with the Michael and Kitty Dukakis Center for Public and Humanitarian Service. The workshop consisted of panels regarding the research methodology on gender and biography, specific historical examples from the European (mostly the South-East European context) as well as presentations on local history – a brief historical account of women's lives in the area of Thessaloniki, Greece. The workshop aimed to expand knowledge and enhance visibility of a broad variety of aspects of the lives of women as depicted in the context of social relations and historical events during the course of the 20<sup>th</sup> century. The case studies presented satisfied the exigencies of auto/biography as a historiographic genre in the field of social and political life. A number of participants presented the results of their research in related fields (Aigli Brouskou, Krassimira Daskalova, Maria Hadjipavlou, Kathryn A. Kozaitis, Maria Kyriakidou, Simona Morganti, Ruth Sutton and Laura Strieth).

The Women's History Association of Ireland has remained active throughout the last year with a number of important events and Most recently conferences. the annual conference was held in May 2012 at the Mater Dei Institute of Education (a college of Dublin University), organized by WHAI committee member Dr. Leeann Lane. The theme was '1912: Irish Women before the Revolution' and included a keynote address by Dr. Senia Paseta of Oxford University. Executive member Dr. Leeann Lane also published her monograph Rosamond Jacob: Third Person Singular (Dublin: UCD Press) in 2010 and gave a keynote speech to the WHAI Annual Conference at University College Cork (UCC) based on her research which addressed the conference theme of Gender and Sexual Politics in Ireland. At the annual general meeting two new members were elected to the executive committee, Dr. Sarah Anne Buckley of NUI Galway and Dr. Elaine Farrell of University College Dublin. We thank outgoing members of the WHAI committee, Mary Clancy, NUI Galway, Dr. Sandra McAvoy, University College Cork, and Dr. Carla King, St. Patrick's College Dublin, for their years of service and we look forward to collaborating with them as members in the future. As a result of the 2011 conference at University College Cork, executive members Mary McAuliffe, Sonja Tiernan, Sandra McAvov and Jennifer Redmond will be publishing an edited collection which they are currently working on coordinating.

President of the WHAI, **Dr. Mary McAuliffe** published an essay on an important piece of legislation in the history of twentieth century women's working lives, titled 'The Irish woman worker and the Conditions of Employment Act, 1936; Responses from the women senators'. She also published another article of a more contemporary nature, 'An Equal and Just Society? Towards Recovery: The Programme for a National Government (2011-2016)' which appeared in in *The Citizen*, Issue 4, in September 2011. Mary is

Dr. Redmond also chaired a panel with cocouncil members, Dr. Sonja Tiernan and Dr. Mary McAuliffe for the American Association of Irish Studies (ACIS) conference held in New Orleans in March 2012. This is the largest Irish studies conference in the world and the WHAI panel addressed women's history themes related to migration, sexuality and political action in a panel titled: 'Erin's Daughters at Home and Abroad: Gender Perspectives on the Twentieth Century'. Dr. Sonja Tiernan spoke on 'Ireland, 'never an army of conscripts:' the importance of women to the anti conscription movement of WWI'; Dr. Jennifer Redmond spoke on 'Erin's Forgotten Daughters? Irish Women Workers

in Britain during World War II'; and President of the WHAI Dr. Mary McAuliffe spoke on 'Once I came over to England I thought, I'm free, nobody will ever take me now': Oral Histories and Magdalene survivors in the UK.

'She said she was in the family way': pregnancy and infancy in the Irish past, (forthcoming, Institute of Historical Research: London, 2012); and 'The Stethoscope and the Travel Permit: Irish Women in the Medical Profession in Britain during WWIII' in Mary Hickman and Jim MacPherson (eds.), Irish Women and the Diaspora: Theories, Concepts and New Perspectives., (forthcoming, Manchester University Press, 2012). The WHAI also hosted its annual Autumn Seminar in December 2011, the theme of which was 'Historians on Historians; the

Dr. Tiernan was also involved in the exhibition, Hilda Tweedy: A Link in the Chain having researched, written and curated an exhibition on the legacy of Hilda Tweedy, founder of the Irish Housewives Association, a non-political, non-sectarian pressure group founded during the Irish Emergency of WWII. The exhibition was launched in Trinity College Dublin in November 2011 commemorate the centenary of Hilda's birth. The exhibition went on display through the Dublin City Public Libraries during 2011-12. In celebration of International Women's Day Dr. Tiernan brought this exhibition *Hilda* Tweedy: A Link in the Chain to Liverpool Hope University in March 2012. She was also interviewed along with Margaret MacCurtain on The History Show, RTÉ, Ireland's national broadcaster, about the life of Hilda Tweedy and the legacy of the Irish Housewives Association by presenter Professor Diarmaid Ferriter.

Outgoing committee member Mary Clancy, NUI, Galway, spoke on 'Recruiting peace and war: gender and public agency during the First World War' at the 8th European Feminist Research Conference, Budapest, May, 2012. She was also involved in the successful NUIG-UL Gender ARC postgraduate summer school, Gender, Discourses and Identities: Gender, Nation, Text, at NUI Galway from 6 to 8 June 2012.

WHAI member Cliona Rattigan published her monograph, 'What else could I do?' Single Mothers and Infanticide, Ireland 1900-1950. This powerful book explores the history of single mothers and infanticide in Ireland over a 50 year period. Based primarily on underused archival material from the Central Criminal Court in the National Archives of Ireland, 'What Else Could I Do?' provides a detailed analysis of the diverse experiences of unmarried mothers who faced criminal charges because they were suspected of having committed infanticide. Although statistics relating to female perpetrators of serious forms of crime are examined, the history of single women who killed their illegitimate infants cannot be understood through official numbers alone. The book undertakes a detailed case-bycase analysis of the records of over 300 infanticide cases tried in Ireland - both North and South - during the first half of the 20th century. This timely study will make an important contribution to historical scholarship and adds considerably to existing knowledge of female criminal behavior in Ireland. It is also a major contribution to the historical understanding of gender relations, class, sexuality, and family life. Whose problem is to balance private life and political career among politicians in Slovenia?

The international conference with key note speakers Joanna McKay (Nottingham Trent University, UK), and Milica Antić Gaber (University of Ljubljana) was organized by the Faculty of Arts (Department of Sociology), University of Ljubljana, 30th March 2012. The conference, a part of the project *Reconciliation* of *private and professional life as an obstacle* for *more numerous presence* of *women* in *politics*, explored major obstacles women face when entering the sphere of politics, balancing the responsibilities of their private and professional lives.

The conference focuses on the global history of domestic workers in private homes, a labour market that over time has included, in addition to physical labour, care for infants, children, and the elderly ("emotional labour").

Work done outside of homes in (small) business or caregiving institutions (hospitals, old people's nursing homes) will be the topic of a later conference. Domestic work, now designated as "domestic caregiving" work, has also been assigned to men in the racializations that (colonial but also postcolonial) societies imposed on men of colours-of-skin other than white. Work in households other than one's own is not only a global phenomenon with area-specific variations and regimes, it is also one with a history extending over centuries and changing over the ages, e.g. the shift extended families nuclear families - dual-income families. Migration of women to such service positions is not as new as some observers claim. Nevertheless, the social sciences have failed to develop analyses with both long-term historical and global perspectives. The recent ILO Convention "Decent Work for Domestic Workers" (2011) is the first international agreement in which domestic workers had a voice.

In the last decade research, esp. feminist research, has increasingly paid attention to the global history of domestic employees ("servants") and to caregiving in private homes. These workers, the vast majority of whom have been women, have always been especially exposed to employer arbitrariness and have had a particularly weak negotiating position. Their working conditions were and are usually hidden behind the walls of the "private sphere." Conditions and positions vary depending on societal structures for example between Latin America, China, and Europe. The history of domestic workers is and always has been a history of migration.

While the migrant status has often been used to explain the neglect of these women in the history of the labour movement, working in the households of strangers and migration for household labour has, in fact, a far longer history than the industrial labour movement. Research needs to include free and unfree workers, live-in domestics and service personnel with their own accommodation, men and women, adults and children, but not apprentices in workshops that are housed in masters' homes.

"Towards a Global History of Domestic Workers and Caregivers" in long-term perspective aims at developing an analysis that, by bringing this neglected category of working women and men into focus, will contribute to a new, comprehensive history of labour. What are the similarities and differences both between the world's regions and over time from the early modern to the modern period? What transfers occur? Present-day domestic work will form the core of the analyses but a historical approach is indispensable. Presenters from across the globe will help avoid a Eurocentric focus.

## **Keynote**

The relationships between paid, unpaid, and forced (slave) labour and reproductive work in a comparative perspective taking account of differentiated developments across the globe. The paper needs to deal with slave labour in domestic settings, common in some macroregional cultural structures to mid-20<sup>th</sup> century, and with the export or labouring women by remittance dependent economies.

# 1. Section: Domestic work and caregiving labour in the households of others – changing definitions and concepts

Conceptual and social historical introduction to the conference theme und the development since the mid-19th century and, perhaps, comparatively the early modern period,

including references to slave labour; a survey and analysis of the multiple societallystructurally differentiated forms of domestic and caregiving work; analysis of its role in the political economy of societies with examples from major regions on different continents.

This survey needs to incorporate attempts to professionalize the sector at the turn of the 19<sup>th</sup> to the 20<sup>th</sup> century in view of both labour shortages and mechanization of household tasks. For the present the assembly-line-type time and motion studies of care work and the concomitant dequalification need to be discussed.

Continuities and discontinuities of definitions and terms will be discussed in a global perspective.

# 2. Section: Changing division of labour – the relationship between workers and employers in private households

The core question remains: Who works for whom? How did the constitution of power relationships regarding gender roles and ascriptions, of ethnicity and class, change over long historical periods? How do such power relationships emerge and how are they perceived in global perspective? How may the concept of "Otherness as a resource," as an entry-gate to bordered wealthy societies, be included into the analysis? How did working conditions and employee-employer relations adapt to the change from private contracting to profit-oriented agencies and large domesticssupplying businesses? This Section's goal is a discussion of the global division of labour and global inequality as regards reproductive labour in a long-term historical perspective.

# 3. Section: Working conditions and reasons to seek and accept work in the households of others

Working conditions for domestic and caregiving workers are often described as

degrading. But many similarities notwithstanding, attention needs to be paid to variations over time and space. Work in the context of live-in arrangements may make sense as cost-saving arrangements – especially for migrants who need to defray the cost of migration and who need to acculturate. Migration may be intended to improve the financial situation of the respective worker's family, it may be an opportunity to sponsor migration of the family, or it may be a strategy to escape from extremely unequal gender hierarchies in the society of origin. While such work may be seen as dirty and degrading, it may also be perceived as well-ordered, gratifying, and satisfying, or as doubly exploitative physical and emotional labour. Such work may have to be accepted under duress or force, it may be wage-work without emotional attachment, or it may serve as training period. Some live-in employees experience lifelong dependency exploitation, others assume positions for a limited period of time to prepare for labour in and management of their own households. Working conditions vary between live-in service and daily commuting to work either from self-rented accommodations or the employees' own family household. Migrations may involve intra-regional or transcontinental moves; they reflect both dynamic and ossified (micro-) regional and global divisions of labour. It is the goal of this Section to analyze the broad range of motivations and lifeprojects of domestic workers in global perspective as well as the role and impact of state and international regulation in the legal and political sphere.

# <u>4. Section: Mobilization – resistance – organization</u>

The history of the labour movement has long regarded political and trade union mobilization of workers in the domestic sphere as weak or non-existent since processes and organizational structures usually did not correspond to those of the industrial, male

unions. Like proletarians in factory labour, domestic and caregiving workers often have no other options or means to feed themselves and their families. But the latter are subject to particular constraints due to the intimate relationship of the secluded home, to the walls separating the "private sphere" from outside scrutiny. For domestic and caregiving workers resistance against unacceptable working conditions often involves resistance against unacceptable living conditions. What types and patterns of resistance emerge over time? How do groups of workers, especially women, mobilize and organize to improve their working conditions? What is the impact of global networking?

Thus this conference expands the traditional history of both the classic labour movement and the history of male and female working-class culture in the productive sphere by incorporating the reproductive sphere – including care for children and the elderly ("emotional labour"). Work regimes range from paid to enslaved household work. The overall goal is an inclusive gendered history of men's and women's work in the inextricably entwined spheres of productive and reproductive work.



# Last but not least: New publication: Key Texts in Gender Politics I-II

Female suffrage, prostitution, compulsory military service, marriage, breadwinning, birth control, sexual rights, parenthood, ideals of beauty, discrimination in working life, forced sterilization and honour-related violence are a few examples of issues in Swedish gender politics from 1839 to 2002.

This collection of texts offers a background to equality policy and today's debate in Sweden about gender politics, as well as a deeper understanding of how sex and gender have been discussed, politicized, constructed and staged.

Key Texts in Gender Politics I–II consists of some 40 Swedish historical texts, with analysis and commentary by researchers who put them in their historical context.

Some of the texts republished in these two volumes were of great significance when they first appeared, or influenced the subsequent development of gender politics. Other texts serve as keys to historical debates on gender politics or illustrate the arguments of specific actors in the debate.

Vol. I has the subtitle "From Critique of Marriage to Sex Education" and covers the period 1839–1930. Vol. II has the subtitle

"From Population Crisis to the Taliban Speech" and covers the period 1930–2002.

The CCWH held its annual meeting, reception, and luncheon at the American Historical Association in Chicago, January 2012. The Board and Business meeting convened on Thursday, January 5 at 4:00 p.m., and a reception was held Friday evening, cosponsored with the Committee on Lesbian, Gay, Bisexual, and Transgender History and the Peace History Society.

On Saturday, January 7, the CCWH hosted its annual awards luncheon. The keynote speaker for the event was Karen Offen of the Clayman Institute at Stanford University. She spoke on "Taking Women's 'Influence' Seriously as a Historical Issue." The recipients of the 2011 awards were announced and recognized at the luncheon. La Shonda Mims is the winner of the Catherine Prelinger Memorial Award for 2011. With this award, she will be able to submit her dissertation on lesbians in the New South by the summer of 2012. Her dissertation research examines Charlotte, North Carolina, and Atlanta, Georgia, as these two cities share an important place in New South lesbian history as sites of urban connection and identity information. Her study reshapes the story of southern women's history, but also the story of the twentieth-century Sun Belt South. Rebecca Hall's article, "Killing Me Softly: African American Women, Slave Revolts, and Historical Constructions of Racialized Gender," The Freedom Center Journal 1, no. 2 (Fall 2009), is winner of the 2011 Nupur Chaudhuri First Article Award. The winner of the 2011 CCWH/Berks Graduate Student Fellowship is Jennifer Lambe from Yale University, whose dissertation is entitled "Baptism by Fire: The Making and Remaking of Madness in Cuba, 1899-1980." The winner of the 2011 Ida B. Wells Graduate Student Fellowship was Cynthia R. Greenlee-Donnell from Duke University, whose dissertation is entitled "Daughters of the Nadir: Black Girls in South Carolina's Jim Crow Courts, 18851905." NATIONAL COLLABORATIVE FOR WOMEN'S HISTORY SITES

NCWHS members have much to report. Recently, NCWHS members were thrilled to learn that US Secretary of the Interior Ken Salazar has committed to increasing the number of women's history sites and the interpretation at existing ones, naming the NCWHS a model partner. Secretary Salazar announced this intention at a March 17 Town Hall discussion at the Maryland Women's Heritage Center that he hosted as part of Interior's ongoing efforts to capture and tell a more inclusive story of America. In addition to two top National Park Service officials, Ms. Peggy O'Dell and Dr. Stephanie Toothman, Baltimore Mayor Stephanie Rawlings-Blake, First Lady of Maryland Judge Katie O'Malley, Acting Assistant Secretary for Fish, Wildlife and Parks Rachel Jacobson, and more than sixty leaders in the women's history and heritage movement attended. NCWHS was active at the 2012 Organization of American History conference. Members of the National Collaborative for Women's History Sites had their annual meeting on Friday, April 20th at the conference. The annual meeting started with a continental breakfast at Frontier Airlines Center and was followed by NCWHS' OAH/NCPH session, "Lessons Learned in Researching, Preserving, and Interpreting Women's History at Historic Sites." The speakers were Peg Strobel (University of Illinois-Chicago and ex-copresident of CCWH) Heather Huyck (President-NCWHS and a member of CCWH),

Beth Boland (NPS Heritage Education Services) and Pam Sanfilippo (US Grant NHS). Connie Sexauer (University of Wisconsin-Marathon County) was the commentator.

UPSTATE NEW YORK WOMEN'S HISTORY ORGANIZATION

The Upstate New York Women's History Organization (UNYWHO) recently held a conference on April 21, 2012 on the Binghamton University campus. conference was co-sponsored by the Journal of Women's History, edited by Jean Quataert and Leigh Ann Wheeler at Binghamton. Susanne Klausen of Carleton University in Ontario delivered the keynote address on her new project on abortion in South Africa during Apartheid. Klausen was the recipient of the Journal of Women's History's bi-annual prize for best article published in the JWH from 2009-2010.

The conference also featured eight panels on a variety of women's, gender, and sexuality history themes, including "dressing women's bodies," "sex and state regulation," and "gender and the language of the family." Panelists included faculty and students from universities in upstate and downstate New York, Connecticut, New Jersey, Pennsylvania, and California. Panel presentations ranged from graduate students working on their dissertations to distinguished historians presenting on new topics for book projects and articles, but regardless of their previous experience many who attended found the conference to be helpful and rewarding. This type of smaller, regional conference has allowed for a deeper sense of community among women's historians.

UNYWHO, an organization formed in the 1970s, was resurrected recently as a networking and knowledge-sharing organization for women's historians

throughout upstate New York. The 2012 Binghamton conference was the second since the organization's revival. In 2009, a conference was held at Hobart and William Smith Colleges in Geneva, New York.
